TERMS & CONDITIONS OF SALES

All Sales made by Badger Tag & Label Corporation (Badger Tag & Label) are subject to the terms and conditions set forth below. All credit extended pursuant to this credit Agreement (Agreement) is subject to such conditions of sale. Payment terms are Net 30. Terms or conditions of any purchase order or other form issued by the customer, which are in addition to, modify or are inconsistent with the terms and conditions will not be binding upon Badger Tag & Label unless agreed to in a separate writing executed by an officer of Badger Tag & Label.

Limitations of Warranties. We warrant this product is of merchantable quality. WE MAKE NO OTHER WARRANTIES, WRITTEN OR ORAL, EXPRESSED OR IMPLIED, AND DO NOT WARRANT FITNESS FOR A PARTICULAR PURPOSE. We shall not be liable under these warranties or on any other ground for damages in an aggregated amount greater than the price paid for the product.

Inspection: Customer shall inspect the products immediately on their arrival at Customer's place of business and shall, within five (5) days of their arrival, give written notice to Badger Tag & Label of any claim that the products do not conform with the terms of the contract. If customer shall fail to give the notice, the products shall be deemed to conform and customer shall be bound to accept and pay for the products. Customer expressly waives any rights the Customer may have to revoke acceptance after the five (5) day period.

Limitation of Actions: All Claims for alleged defects shall be deemed waived unless made in writing, along with samples demonstrating the complaints, within thirty (30) days after receipt of goods. No action regardless of form arising out of the transactions under this agreement may be brought by Customer more than one year after the cause of action has accrued. The exclusive remedy of Customer in the event the product does not conform to the description or the warranty herein shall be the repair or replacement of the product at the option of Badger Tag & Label.

Taxes: All amounts due for taxes and assessments will be added to the customer's Exemption Certificate accompanies the credit application. If after the customer has paid the invoice, it is determined that more tax is due, than the customer must promptly remit the required taxes to the taxing authority, or immediately reimburse the provider for any additional taxes paid.

Insolvency of Buyer: If customer makes an assignment for the benefit of creditors, or admits in writing its failure or inability to pay its debts as they become due, or becomes the subject of an "order for relief" within the meaning of that phrase in the US Bankruptcy Code, or applies for or consents to the appointment of a receiver for any of its property, Badger Tag & Label may terminate any agreement arising out of or relating to this Agreement, at any time, effective immediately upon such notice. Such termination shall not relieve either party from any obligations accrued hereunder up to the date of notice of termination.

Change in Terms: Badger Tag & Label reserves the right at any time to suspend credit or to change credit terms provided herein. In such a case, in addition to any other remedies herein or provided by law. Customer may be required to submit cash payment of satisfactory security before manufacture or shipment, or the due date of payment by Customer may be accelerated by Badger Tag & Label's acceptance of less than full payment shall not be a waiver of any of its rights to full payment.

Cost of Collection: If Badger Tag & Label commences an action against the customer arising out of or in connection with this Agreement or any agreement arising out of or relating to this agreement, Badger Tag & Label shall be entitled to have and recover from customer its reasonable attorney's fees, collection costs and costs of suits.

Complete Agreement: The Terms and Conditions set forth herein supersede all other proposals, oral or written, and all previous negotiations, conversations, or discussions between the parties to this agreement. Customer understands and agrees that no agent, employee, or representative of Badger Tag & Label has authority to bind Badger Tag & Label to any affirmation, representation or warranty concerning the subject matter of this agreement which is not set forth herein, and that any affirmation, representation or warranty which is not set forth herein shall not constitute a warranty.

Confirmation: As an Officer or Principal of the Company named above, I hereby warrant and represent that the information provided herein is accurate and correct, that I have authority to execute this document, and that the company agrees to be bound by the terms and conditions of sale set forth herein. I also authorize release of necessary bank and credit information to Badger Tag & Label and agree that our credit history with Badger Tag & Label can be shared with credit reporting and industry credit groups.
